- 1. I think he should resign at this point given the totality of his statements and the need for the Bar to appear impartial and also dedicated to equal access to justice. The comments and backlash have proven too divisive. He should resign for this reason alone so this is not a distraction.
- 2. The original post regarding electioneering actually raises big questions that were raised by the Supreme Court in the 2018 Mansky case. His general discussion of these issues, in isolation, should not make him unfit, although I think the discussion could have been more nuanced or intelligent. But his calls that "she should have been immediatley arrested" seemed hostile and racist to me.
- 3. The blog post calling Black Lives Matter a terrorist organization and the other post commenting on an addict "being hot" before becoming addicted to meth are deeply offensive and should not be associated with anyone serving at State Bar President.
- 4. The combination of his calls for the pollworker to be arrested in light of the claim that BLM was a terrorist organization leads me to believe that he is racist and should absolutely step down.
- 5. I think the State Bar should acknowledge that it did not make any stand or support over Black Lives Matter in 2016 or prior to this controversy (at least that I recall). Maybe the bar has work to do as well.

In re: Larry McDougal

The State Bar of Texas never sought permission directly from the (compulsory) membership to oppose the plaintiffs in the McDonald v. Sorrels bar-deunification litigation. The Texas Bar nevertheless opposed them, continues to do so and consequently remains far more spread out into diverse political & other controversial activities than do attorney licensing entities in states where most other U.S.-licensed attorneys practice (such as CA, NY, VA and WA [etc.]). As a result, public disagreement about the views of any particular Texas Bar board member or (most recently) the president counterproductively remain more relevant than they need to be, and still potentially hold the entire legal profession in Texas hostage. The resulting politically charged climate involving the Texas Bar is consequently particularly vulnerable to being unduly influenced by (varying) segments of the internet's rage mob. The situation is unfairly oppressive to board members and especially to the president, as we have recently observed. You all deserve to have the right to have your opinions about public (and private) matters, and to voice them when you see fit. Dear Sirs and Madams:

I am appalled by the joint statement made by the State Bar of Texas and Texas Young Lawyers Association concerning Larry McDougal and Black Lives Matter. As a member in good standing for 33 years I am shocked at the rush to judgment against Larry, who has never made a racist comment in the 30 years I have known and practiced law with him. Larry has always been a man of integrity, kindness, and a huge heart as large as the State of Texas. Larry expressed a private legal opinion, which was correct, by the way. Larry, like many of us, has been under attack for years by those in the legal profession who hate conservatives and liberally use profanity on Texas legal sites to express themselves.

Did any of you listen to Larry and consider his position, or were you so eager to pander to Black Lives Matter (hereinafter BLM) that you lost all reason? And, how many of you could stand up to intense biased scrutiny of every private opinion you had uttered in the last 6 or more years?

In 1992, the U.S. Supreme Court upheld an electioneering ban at polling places, meaning that states had the power to create laws to prevent voter INTIMIDATION (emphasis added) and ban electioneering around polling places. Texas states that a person "may not electioneer for or against any candidate, MEASURE (emphasis added), political party" within 100 feet of the voting site during early voting or on Election Day. To the Members of the State Bar Board -

I am writing to request the removal of Larry McDougal as the State Bar President.

Mr. McDougal's apology focuses solely on his "intent." To him, the fact that his words have harmful impact is just a secondary issue. His statement removes the focus of the harm from the people he has harmed, and puts the focus back on him. This leaves our colleagues of color with the burden of navigating the harm he caused. They are expected to carry on and not make a fuss, because it is too hard, too scary, too unfair, too harsh, too much, to expect a White man to acknowledge that his statements contribute to the greater systemic racism inherent in American society, and our Bar.

Mr. McDougal wants no part of any conversation that doesn't allow him to be absolved of any consequence for his actions. He demands to be accepted as he is, with no ramifications for what has gone before, just because he said he's sorry. That is both Male Privilege, and White Privilege.

In matters of race and racism, intent DOES NOT MATTER. That is the privilege of White Fragility, to excuse racist impact because, "That wasn't my intent" or "I didn't mean it that way" or "You took it wrong." The IMPACT of Mr. McDougal's words and actions on our colleagues of color is what matters here. The impact that makes them feel less than, unequal, smaller, scared, and devalued.

He demands forgiveness from the group he has harmed, and then expects it unreservedly. It is not on our colleagues to put this "error in judgement" aside because he throws up his hands and says, "I apologized; I don't know what else to do." The fact that he thinks it is enough demonstrates his lack of understanding about the harm his comments have caused, and it is a glaring, real-time example of the systemic racism that exists today, right now, in our society, and in our State Bar. If Mr. McDougal really absorbed the impact of his words and saw how his actions continue to promote racial inequality and perpetuate harm to his colleagues of color, he would voluntarily step down.

When addressing his 2015 statements in his apology video, he states that he "feels the opposite now," but he doesn't actually acknowledge that "Black Lives Matter." He doesn't say, specifically, that he knows now, for certain, in 2020, that Black Lives Matter is NOT a terrorist organization, but a civil rights movement. He doesn't offer any support for Black Lives Matter. What he doesn't say when he has the opportunity speaks louder than any apology he can give. HE wants the forgiveness, HE wants the attention, HE wants the time devoted to educating HIM. This is classic passing-the-responsibility buck. He can do the work and educate himself. We are lawyers. We know how to research.

Mr. McDougal's apology also does not reference his recent statement on the Texas Lawyer's Facebook page regarding a citizen poll worker wearing a Black Lives Matter shirt. That statement, combined with his prior rhetoric about the Black Lives Matter movement indicates that his opinions regarding Black Lives Matter have not changed. He states that the person wearing the shirt at a polling place was doing so to intimidate voters. He still sees BLM, and the people supporting the movement, in this case a Black woman, as a threat. He still sees Black people as "Others," to be feared and cautioned against. In posting

that message as State Bar President, that is what he conveyed to all the members of the Texas State Bar. His words represent the Texas Bar world-wide, because his words have been captured and shared and re-shared. They have gone global. That is his impact. To support him as Texas State Bar President is to support continued systemic racial oppression against our colleagues of color.

As a woman of Anglo and Mexican heritage who has always reaped the benefits and privilege of living White, I put this burden back on us. We must acknowledge it, and we must make the change, including removing him as the State Bar President. Otherwise, for our colleagues of color, it's just another meaningless apology from a White man who promises to "do better," while the racists systems stay in place, and nothing changes.

Beyond this, I'm thinking about my friends and colleagues who were deeply hurt by Mr. McDougal's comments. My friends who are openly harassed by White Bar members online and in person over this very issue, who are being asked to justify their right to feel hurt and devalued by his words. Their presence in my life matters. They matter. Their lives, their service, their expertise, their participation in the Bar matters. The Bar would miss their perspectives, knowledge, and every good and positive thing they bring to the table. We must stand up for them. We must acknowledge that they matter. Mr. McDougal is not the State Bar President we need right now.

Amy and Todd:

I am messaging you regarding President McDougal. At the outset, I am not at this point demanding his resignation. I want to see his response to the AALJ section's proposals (which I realize due to his emergency surgery will not be as soon as people probably wanted). Depending on his response to that, my opinion to resignation and/or harsh board action may shift.

That said, I have significant concerns regarding the statements President McDougal made last week on social media as well as in the past (i.e. including referring to an attorney with a drug issue as "hot").

I have viewed his Youtube video apology as well as his initial statement put out with by the Bar. I have also read the letter put forth by the AALS section calling for specific measures. I am generally in line with the proposals stated in the AALS letter (perhaps a little milder on what the President needs to do in number one), and have long thought that implicit bias training should be required (I went to a Austin Family Law Section one with Mindy Gulati and it was one of the best CLEs I have attended).

Beyond the statements Larry McDougal has made, our Bar is an extremely unwelcoming place for minorities and women. Sometimes it's hard to see unless you are online or talking to other colleagues. I consider myself lucky because I practice mainly in Travis County (as well as the surrounding ones) and I know here it is better than many places in Texas.

That said, I have heard male colleagues in both areas of law where I practice [family law and personal injury] refer to our female judges as "stupid" or "idiots." The male judges somehow just ruled against them (because you know white men don't lose, they just get bad rulings).

Up until a few years ago, I would still hear or uh see a colleague make remarks regarding an attorney or judge regarding their sexuality or "rumored" sexuality. No, I wasn't asking, because WHO CARES.

I was also at UT Law the first year of Hopwood (UT 2002). There were 4 African Americans in my whole class. It was a widely held belief while there that well those were the only ones who clearly "deserved" to be there. The next year George P Bush was admitted. His GPA was 2.75 (this came out recently and it's not to disparage him simply to point out how much Hopwood was some sort of 100% merit system for entry).

Over the past few days, I have commented on several attorney forums and personal social media pages regarding adopting an ABA model rule regarding ethics and attorneys (it ties to the ability to grieve an attorney). I also commented that we needed implicit bias training as mandatory CLE immediately. I was immediately told that I would not be shoving my agenda down someone's throat. Frankly, that is one of the kinder responses I have heard. Many attorneys have commented in response to the debate that BLM is a Marxist organization I have also seen comments from attorneys that are basically love it or leave it-don't practice law if you can't handle the criticism. I have seen comments that Larry has done much for the little guy (somewhat true) and was elected on that platform so you should get behind and support him or you don't care about grievance reform, small firms or mental health. The lack of decorum is horrific and it has been especially and brutally leveled against people of color and doubly so for females of color.

In conclusion, the Bar has a systemic problem with race and gender issues. This needs to be addressed both by the President and the Board. I make no judgment as to whether Larry McDougal is a "racist." I do not personally know him. I do however believe his remarks his statements have been are racially and sexually unsound and irresponsible regardless of the time frame in which they were made or Mr. McDougal's own personal experiences that led him to these words.

We need to do better. We must do better. A mere taskforce that was already in the works is not enough (though I am not opposed to it). We are not just any professional trade association-we are attorneys-advocates for justice. In many instances, the last desperate hope for people. We are given tremendous power by virtue of our Bar Cards both in effecting individuals and our governmental institutions. This isn't a restaurant owner who posted something. I hope the Directors listen to those who have for so long felt hostility and hate within their own profession.




Dear Bar Directors,

Chairman Ginn and Members of the Board of Directors of the State Bar of Texas,

I write to you today as a citizen and member of the public regarding the recent comments made by President McDougal on his personal Facebook page as well as the response to date from the State Bar of Texas as well as several sections and other individual members of the Bar. After witnessing the aggressive and rapid response by the Bar's leadership, I felt compelled to relay my feelings on this matter directly to the members of this Board of Directors.

First, I do not believe that President McDougal is a racist. I was privileged to serve as a public member of the Board of Directors, appointed by the Texas Supreme Court, from 2017-2020. I worked closely with President McDougal during his President-Elect year of 2019-2020 in my capacity a Chairman of the Audit & Finance Committee. We served together on the Budget and Executive Committees. We had many conversations both at board and committee meetings, as well as one on one conversations in person and by telephone. I would like to state in the clearest possible way that never once did I ever hear President McDougal speak ill of anyone ever. To the contrary, I listened to him on many separate occasions speak in passionate terms of his vision for the future of the Bar and ways that he thought he could make a difference—for ALL lawyers that are members of the State Bar of Texas. I feel certain that members of the board as well as the professional staff of the State Bar of Texas who worked closely with President McDougal will attest to this fact.

Secondly, President McDougal is the elected leader (by a majority of the lawyers licensed in the State of Texas) of the State Bar of Texas. He has served his community as a dedicated first responder, both as a firefighter and police officer. He has served the public and the legal profession as a former Director of the State Bar, President-Elect and now as President of the State Bar of Texas. He is also a successful criminal defense and family law attorney practicing in Richmond, Texas in a law practice that he built and has continued to grow with his son and law partner. Last I checked he is <u>not</u> a media professional who slickly operates in and adroitly maneuvers in the increasingly toxic world of social media and the twenty four hour news cycle. President McDougal is a plain spoken country lawyer who is not afraid to speak his mind and call things like he sees them. In his comments relating to members of the BLM movement and their actions one could disagree with his assessment of this organization, but because President McDougal's assessment may differ from one's own does not and should make him a racist. A Facebook post should not define a lifetime of work and service to his community and profession.

While I will not second guess the actions of my friends in Bar leadership in their swift condemnation of President McDougal and his Facebook post, I do suggest that their aggressive actions have fed a fire that may very well drive President McDougal from office or severely cripple his presidency. As I watched the social media explosion that began on Saturday build and build it has become increasingly clear to me that there may be nothing President McDougal can do or say at this point to appease those who are railing against him. From the outside and as a non-lawyer, it appears that due process was thrown out the window in this instance. While it may be too late to save President McDougal's presidential year, I hope that the leadership of the Bar will learn from these events and will develop policies and training for those holding high office at the Bar, including as members of the Board of Directors, that will be designed to remind and assist those in office to self police and

monitor their tone and messaging on social media. While one may believe that they are espousing their own personal beliefs and not those of the State Bar of Texas, it only takes a few re-posts or retweets for something to go viral and take on a life of its own.

President McDougal is not a racist. His apology should be accepted and he should be allowed to serve out the remainder of his term. Members of the Board should work with him and President-elect Sylvia Borunda Firth to develop policies and training to guide the conduct of all board members and elected leaders of the Bar as it relates to social media. Most importantly, all of us should be respectful and listen to one another's opinions and not be so quick to condemn them. The future of our society depends on this dialogue and the lawyers of Texas should lead by example.

Thank you for allowing me to share my thoughts on this subject and for all that each of you do for Texas.

I write to support the need for fair treatment of SBOT President Larry McDougal.

In reviewing the enabling statute, I did not see any mechanism for removal of the President. However, looking at Sec. 81.027, I see that the directors may be removed only for specific reasons. Surely the president should be treated no less fairly than a director. I do not know President McDougal well, having met him only twice. Election law is not my specialty and I cannot say whether Larry's opinion was correct or not. Nor do I condone his years-old posts which he has addressed. However, it does not appear that if he were a director these would constitute grounds for removal.

In addition, I find it curious that the Board acted first and solicited member comments after the fact. While I did see the open letter and the later call for comments on the SBOT Facebook page, I did not see any notice of the meeting at which the Board considered its statement, with the usual open meeting notification as to public comment, nor do I see any Meeting Agenda and minutes on the SBOT website.

Fundamental fairness and respect for due process should be hallmarks of our profession, and President McDougal should be afforded same.

I am troubled by the comments which have been reported from Larry McDougal. My understanding is that this was initially made on a lawyer facebook page. I used to be involved in a couple of these pages, and left because they are so divisive. Even after multiple conversations with Andrew Tolchin about these groups and their value to the bar, I have not participated in several years.

I have served with Larry on the CLE committee for several years and found his comments and suggestions worthwhile and helpful to that group. When he came to Tyler, because of that relationship, I was happy to introduce him to attorneys in our area. And while I appreciate his comments in response, I am very concerned that this issue will drive apart the bar. I think that Larry should strongly consider resigning for the good of the bar. While I agree that his views on issues may have changed since 2015 when the first comment about BLM was made, the fact that as state bar president he made this comment in a public forum disturbs me.

That being said, it is my understanding that the two candidates who are chosen to run for State Bar President-Elect are selected from several following interviews. This may also be an opportunity for the bar to change the process in choosing these candidates. I write this email regarding the recent and less-than-recent but recently discovered comments made by Larry McDougal regarding Black Lives Matter, electioneering, and his views regarding addiction and licensure issues. As an active Texas attorney, I was dismayed to learn of them and even more dismayed that Mr. McDougal believes he can separate personal views like this from his service at the president of the bar.

Directors,

I am writing to discuss the recent and past comments made by Larry McDougal, as well as the negative effect those words have had on the local and national image of our Bar. I'm sure you've been inundated with comments, many more eloquent than mine, but I feel compelled to speak out against this disturbing trend before it spirals completely out of control. You have all been upstanding members of the Bar, to my knowledge, and hold positions of leadership that carry much greater weight in addressing these issues than myself and my concerned colleagues.

You have all surely seen Mr. McDougal's comments by now, including his recent discussion of Black Lives Matter ("BLM") and accusation that supporting BLM at a polling site is a crime, his past allegation that BLM is a terrorist group, his misogynistic comments on the appearance and character of a female member of our Bar, and his posting of a picture suggesting police brutality is "justice" that occurs before the trial of an accused criminal defendant. I am not the proper person to explain why any of these comments are so hurtful, but I have listened to our colleagues explain their pain. I have also seen that pain be dismissed, explained away, excused, and mocked—mostly by other members of the Bar. This is part of the disturbing trend that is taking root, or perhaps merely stepping into the light after years of festering, and must be addressed.

Mr. McDougal issued a video apology that fell far short of explaining his behavior. Indeed, he did not even address the entirety of the past comments listed above, nor did he display any kind of understanding as to why his actions were so hurtful. I understand the AALS has issued a call to action and some branches of the Bar and individual directors have condemned some of Mr. McDougal's comments. I am hopeful you will all do the same for the entirety of his unacceptable behavior. If you already have and I missed it, please let me know where I can find your statements.

Unfortunately, the ongoing defense and excusal of Mr. McDougal's comments has also brought to light a pattern of similar behavior by one of the State Bar Directors—Steve Fischer. Mr. Fischer has frequently bullied other attorneys in online forums, often spilling over into racially-inappropriate comments. Among other offensive comments, he accused a female attorney of doing "nothing to help civil rights this week except you're still married to a Black" and downplayed the suffering of Black people in our country in comparison to Jews with the phrase "equal jobs or equal ovens." He also caused pain to some of our colleagues by insisting the death of Ahmaud Arbery was related to his hypothetical criminal record in the wake of his tragic murder and declaring George Floyd should have spent more time in jail in the wake of his tragic murder. This is only the tip of the iceberg for Mr. Fischer's unnecessary, racially-charged, and divisive comments, which also include many misogynistic comments and belittling of female attorneys. I would like to know what the Directors as a group plan to do to address this unacceptable conduct from one of your own.

I understand that some people brush aside online comments or conduct. I've certainly seen that happening over the past week. However, we cannot ignore racism or other inappropriate behavior simply because it occurs in an online forum. Online comments are arguably more troublesome because they reach the public at large—just see the numerous articles addressing Mr. McDougal's comments that are widely available and viewed on sites like Above the Law and Law.com. Rather than engaging his constituents and addressing these issues, Mr. McDougal began blocking attorneys who questioned his comments and has now apparently removed his online presence. The President (and Directors) cannot hide behind the idea that these comments are made in their "personal capacity" when the public does not make that distinction and their behavior demeans us all. Moreover, if these are really their personal views, they are unfit to serve in leadership positions.

I am merely one voice, but if it were up to me, both Mr. McDougal and Mr. Fischer would resign as they have demonstrated they are unfit to serve the entirety of the Bar, specifically our minority and female colleagues. I hope you feel the same way and will make those feelings public. Even if you disagree with resignation, I hope you will see fit to come to the public defense of our bullied and marginalized colleagues who continue to suffer merely because of the color of their skin or their identity as women.

Dear Board of Directors,

I have sent this email to some of the directors in my area, and I'm copying it again here. Thank you for your consideration:

It is certain, in any case, that ignorance, allied with power, is the most ferocious enemy justice can have. – James Baldwin

I am writing to you today because of these wise words from a remarkable American author and civil rights activist and because, today, right now, it is time for the State Bar of Texas to address how it uses its power. Does it use its power in the pursuit of justice for all, or does it use its power to continue to ignore and perpetuate the historical injustices that have plagued our civil and criminal justice systems; to embolden and protect bad actors; to sit silent when the state and country are screaming? Unfortunately, you are faced with answering this difficult situation, but you have been elected to serve, and I can no longer sit in silence.

I don't believe you need me to explain the issues with Mr. Larry McDougal's comments, but it's clear to me that many of my fellow colleagues do not understand the impact of his statements, and the implicit bias, if not outright racism, that underlies his opinions. From the 2012 police brutality meme, to calling Black Lives Matter a terrorist organization, to likening a BLM shirt to a MAGA hat and calling for a Black Texas citizen to be removed and cited for wearing that shirt, it is clear to me that what is in Mr. McDougal's heart, even if there is good there, is also dangerous, precisely because of the power he wields with his bar card and now as president of the SBOT. His apology was lacking and insincere. I do not believe he understands the problem, nor does he truly care to understand it. He issued an apology because he could not ignore it, but not because he believes it. It is after much thought, and not with pleasure, that I ask you to call for the resignation of Larry McDougal. He cannot organize, head, or even sit on a task force, because he has so much work to do. I don't expect him to believe in everything I believe in, but his ignorance on this topic makes him an ineffective leader, and he has lost trust.

I am also asking that you address the embarrassing and damaging behavior of your fellow board member, Mr. Steve Fischer. I have included screenshots of some of his most recent statements to fellow lawyers in facebook forums for Texas attorneys. Mr. Fischer is extremely divisive, and he also uses his wife, a non-attorney, to harass and call out other Texas attorneys. Again, I do not take pleasure in sharing these screenshots, and I do so only after much contemplation on the benefits of doing so. These screenshots were shared by others and some are public statements. If a name is not redacted, it is because they gave me permission to leave their name. In Mr. Fischer's case, his words and actions toward other Texas attorneys must be revealed, as they speak volumes. Over the years, and especially most recently, he has isolated attorneys based on race and gender, has blocked them from facebook groups where he is an administrator, and has refused to acknowledge how he has caused harm.

He speaks loudly about bar reform, but I no longer know what reforms he wants. He should be called to answer for his behavior as a leader on the SBOT Board of Directors. He is not my representative, and, therefore, it is not my place to ask for his resignation, but his actions should not be ignored. He reflects poorly on the SBOT and the board, and, frankly, he has created more harm than Mr. McDougal. I can no longer tolerate it in silence.

Finally, it goes without saying that it is far past time that the SBOT make implicit bias training a mandatory part of our CLE requirements. The California State Bar, of which I am also a member, requires new attorneys to complete 1.5 hours on "recognition and elimination of bias in the legal profession." It is clear Texas attorneys need this. Now. We do not need another task force to tell us what actions to take. We know exactly what must be done and this is a simple and necessary first step. Again, I do not expect my colleagues to see eye-to-eye with me on everything, and I know that opinions are strong on this, but the board must have courage. If not now, when? The horrible injustices in the criminal justice system, for example, belong to all of us lawyers. Every single one of us. It cannot continue. Please, stand for what is right and what is necessary. You can use your power to truly reform and help the bar in a way Mr. McDougal or Mr. Fischer, and those like him, will never be able to do. They want to keep us in the dark ages, but I want to practice law in the light. Do the right thing.







Dear Mr. Apffel:

I am writing as a member of the State Bar of Texas in regard to the incoming State Bar President, Larry McDougal.

I have read two separate articles dated July 12, 2020 and July 13, 2020 in the Texas Lawbook pertaining to Mr. McDougal. I have also seen a statement issued by the African American Lawyers Section of the State Bar of Texas calling for the resignation of Mr. McDougal as well as the joint statement issued on July 11, 2020 by several leaders of the State Bar of Texas and the Texas Young Lawyers Association.

I want to say at the outset that I do not personally know Mr.

McDougal. I have never met him and never spoken with him. I think it is important to note that I have not done any research into the alleged Facebook post made 5 years ago by Mr. McDougal. In other words, I am accepting the allegations at face value. I also want to point out that I certainly do not condone <u>any</u> discriminatory conduct or statements by any person whether a member of the Bar or not.

It is clear that members in our society (and our State Bar) will have differing opinions and beliefs on many subjects such as taxes, healthcare, abortion, gun control/rights, as well as the organization Black Lives Matter. The list could go on and on. It is axiomatic to a democracy that citizens be able to express themselves without fear of retaliation, censorship or sanction. In fact, this is recognized in the First Amendment to the Constitution and has been a bedrock of our society for many decades.

As a member of the Bar, I believe it is important to protect the right to freedom of speech no matter how troubling it may be to some. It was not too long ago that the United States Supreme Court recognized that the right of free speech permitted a person to burn the US Flag. There were many in our society who were opposed to the burning of the flag but our courts recognized such right was protected. Now, it seems that with the advent of social media our society has now become fixated on attacking individuals based on their political views and opinions.

It is important that the leadership of our State Bar protect the sanctity of the right to freedom of speech and that the State Bar does not participate in the chilling of free speech. Without free speech and political discourse, we will lose our democracy.

I implore the leaders of the State Bar to not directly or indirectly condone the chilling of free speech. The State Bar should recognize that it is an organization that casts a broad tent that includes people of all races, creeds, religions, and genders. It has come to my attention that some are calling for Mr. McDougal to resign or alternatively accept certain demands requiring the implementation of new policies such as requiring 2 mandatory CLE hours for all members. This is improper on its face. Any such proposals should be brought up for consideration by the Bar based on the merits of each proposal not used as an attempt to extract certain concessions by an incoming State Bar President in order to preserve his own individual position.

Finally, I must note that the opinions expressed in this message are solely mine and should not be construed as written on behalf of my firm. I believe that each individual in the Bar as well as at my firm are entitled to their own opinions which I respect.

Dear Texas Bar Leadership,

I am not a lawyer, but I have many friends who are lawyers in Texas, and over the past several days, have noted widespread debates between my many Texas lawyer friends (advocating both sides) on my social media threads regarding the comments of Texas Bar President Larry McDougal, and the appropriateness or inappropriateness of Black Lives Matter (BLM) apparel at polling locations.

The response of the Texas Bar to Mr. McDougal sclaim that BLM apparel does not belong at polling locations as it is politically leading is troubling - for a number of reasons. The inappropriate behavior, if in any case, is on behalf of the liberal "leadership" of the bar for turning a blind eye to the issues at hand. The inappropriate behavior rises to a higher level, because the Bar is offering an official, organizational response to an unofficial, private comment, by its President.

The facts are clear regarding BLM, and its association with the Democratic party. As you are well aware, as lawyers, there are laws regarding signage and other forms of steering at polling locations • and it should be perfectly evident that BLM signage 1) could promote votes for dems and 2) drive funding to BLM, as well as other democratic causes and candidates which raise money through ActBlue.com, a registered democratic PAC.

The BLM website raises its online donations, the majority of its funding, through ActBlue.com, which is a registered Democratic PAC. According to the ActBlue website and mission, it is Powering Democratic candidates, committees, parties, organizations, and c4s around the country. So the obvious first question, before delving any deeper, is, why did BLM, if it is not a democratic organization choose ActBlue.com as its fundraising consultant and partner, and payment processing organization. It could have chosen WinRed, the GOP analog. It could have chosen any number of thousands of other fundraising consultants and processors, which were politically neutral. However, it chose ActBlue.com, an organization which openly and publicly states that it only does fundraising for Democratic organizations. BLM states on its website under note 2 on their donor page, ActBlue processes its online donations. The BLM website redirects you to ActBlue.com.

The second issue at hand deals with the cross pollination of donors. WinRed and ActBlue are designed to cross-pollinate Republican and Democratic donors respectively. Advertising or sending traffic to WinRed or ActBlue, can result in donations and fundraising for other Republican and Democratic causes, respectively. The concept is quite novel, and interesting and synergistic business, unless the source of the advertising or traffic is, say, a non-profit university using its alumni email list or a, what is supposed to be, neutral polling site has signage that promotes BLM. ActBlue's fees are outrageously high relative to industry averages - BLM uses them for 2 reasons: 1) they want to align blue and 2) they want to cross pollinate donors.

This is not to say, as has been misreported, that BLM directed donations go to the Biden campaign • they go to BLM. But, it is clear that advertising ActBlue, also helps promote any other campaign being run on its site. The top two recipients of ActBlue funding are the Sanders campaign and the Biden campaign, both receiving over \$100 million through the PAC. The DNC also has received a cool \$22 million plus in checks.

A group of conservative alumni of major colleges, filed complaints against the leading colleges and universities in the US over the past several weeks, as a result of receiving emails using alumni email lists given to provide university updates not promote political causes to guide alumni both to the BLM website, and even more directly, right to ActBlue.com. We now have universities, who are not registered PACs, using their alumni databases given for the purposes of giving alumni updates, sending links both to BLM, and directly to ActBlue.com, a Democratic PAC. As a result of the many complaints, the administration and IRS announced investigations last week into the tax status of schools.

The situation in Texas is no different. BLM apparel may cause steering at polling locations, and further, promoting BLM drives traffic to ActBlue.com, which may also promote democratic candidates. Inherently, WinRed and ActBlue are fine, and an interesting business model • however, when traffic comes from the wrong places, there are clear ethical issues.

The issue is far more important than Larry McDougal. Responsible lawyers should want to try the issue of whether BLM (and perhaps GOP analogs like Blue Lives

Matter) apparel belong at polling locations.

It is the responsibility of Texas lawyers, under the oath they have taken, to preserve the integrity of our democratic processes, which includes the neutrality of polling locations. In not doing so, the Texas Bar and Texas lawyers are failing.

By taking a public stance against Mr. McDougal, the Bar has also rendered itself a non-neutral party for perhaps one of its most important responsibilities • the provision of legal referrals to Texas clients who may have limited legal contacts. Should an individual in Texas, who goes to a polling location and sees BLM apparel displayed, wish to hire a lawyer to dispute it • feeling swayed, pressured, or that electioneering is occurring • he or she should have a neutral Texas Bar to approach for a legal referral. This is no longer the case. In this manner, the Bar has failed.

I am only a citizen, not a lawyer. However, I feel the need to comment on this, as it is the role of all citizens to advocate. The work of alumni of top schools have brought to light the issues which universities, which are now being addressed by the IRS.

I am writing as a member of the State Bar of Texas in regard to the incoming State Bar President, Larry McDougal.

I have read two separate articles dated July 12, 2020 and July 13, 2020 in the Texas Lawbook pertaining to Mr. McDougal. I have also seen a statement issued by the African American Lawyers Section of the State Bar of Texas calling for the resignation of Mr. McDougal as well as the joint statement issued on July 11, 2020 by several leaders of the State Bar of Texas and the Texas Young Lawyers Association.

I want to say at the outset that I do not personally know Mr.

McDougal. I have never met him and never spoken with him. I think it is important to note that I have not done any research into the alleged Facebook post made 5 years ago by Mr. McDougal. In other words, I am accepting the allegations at face value. I also want to point out that I certainly do not condone <u>any</u> discriminatory conduct or statements by any person whether a member of the Bar or not.

It is clear that members in our society (and our State Bar) will have differing opinions and beliefs on many subjects such as taxes, healthcare, abortion, gun control/rights, as well as the organization Black Lives Matter. The list could go on and on. It is axiomatic to a democracy that citizens be able to express themselves without fear of retaliation, censorship or sanction. In fact, this is recognized in the First Amendment to the Constitution and has been a bedrock of our society for many decades.

As a member of the Bar, I believe it is important to protect the right to freedom of speech no matter how troubling it may be to some. It was not too long ago that the United States Supreme Court recognized that the right of free speech permitted a person to burn the US Flag. There were many in our society who were opposed to the burning of the flag but our courts recognized such right was protected. Now, it seems that with the advent of social media our society has now become fixated on attacking individuals based on their political views and opinions.

It is important that the leadership of our State Bar protect the sanctity of the right to freedom of speech and that the State Bar does not participate in the chilling of free speech. Without free speech and political discourse, we will lose our democracy.

I implore the leaders of the State Bar to not directly or indirectly condone the chilling of free speech. The State Bar should recognize that it is an organization that casts a broad tent that includes people of all races, creeds, religions, and genders. It has come to my attention that some are calling for Mr. McDougal to resign or alternatively accept certain demands requiring the implementation of new policies such as requiring 2 mandatory CLE hours for all members. This is improper on its face. Any such proposals should be brought up for consideration by the Bar based on the merits of each proposal not used as an attempt to extract certain concessions by an incoming State Bar President in order to preserve his own individual position.

Mr. McDougal:

I am writing as a concerned member of the State Bar to implore you to stand strong against those condemning you for the �blasphemous� sin of making a comment critical of the BLM organization.

I am not writing in support or condemnation of your past comments, which have garnered much attention. I am writing because I am concerned at the political zeal of a few, loud voices that seek to silence political speech. I presume that you, like me, believe strongly that the lives of black people matter and that they should be treated with the same dignity and respect of all others - without regard for race, religion, gender, National origin, etc.

In my opinion, the BLM organization is a political movement with aims that are not widely supported, such as defunding the police and disrupting the western nuclear family.
