Diane, first, thank you for serving the State Bar. I've been a licensed Texas attorney for over 27 years. I'm sending this from my home email as these are my personal comments. This will be long, but I will cite a lot of material. To make this simpler, when I'm talking, I put it in *italics* and *RLH Comment*: precedes my comments.

By way of introduction, the political issues related to the recent riots and the death of George Floyd that allegedly triggered those riots, is something I've been looking at for several years. Now it's moved to the Texas State Bar Association, and that's sad in and of itself. But there is something worse. • Unapologetically Black in our positioning.

RLH Comment: Let's call this what it is. It's racism, pure and simple!

- Make space for transgender brothers and sisters to participate and lead.
- Do the work required to dismantle cisgender privilege (pro LBGT; more than 2 genders).
- Disrupt the Western-prescribed nuclear family structure.

RLH Comment: One of the biggest problems in the black community is the lack of a nuclear family structure. This is insane – one of the biggest problems in the black community they intend to make worse. They aren't interested in fixing the problems in the black community.

- Foster a queer affirming network. When we gather, we do so with the intention of freeing ourselves from the tight grip of heteronormative thinking, or rather, the belief that all in the world are heterosexual (unless s/he or they disclose otherwise).
- Inspired by Dream Defenders.

*RLH Comment: Dream Defenders wants to end police and prisons* -i.e., they support anarchy.

• Enraged by Trayvon Martin death.

RLH Comment: This is a false narrative of murder when Trayvon Martin attacked a Hispanic (George Zimmerman) and was killed. Zimmerman was found not guilty. The prosecutor in the case failed miserably by not voice printing Zimmerman and the 911 call. The case would likely have been dropped since it would likely have showed Zimmerman was being attacked, was screaming when Martin was on top of him beating him, and shot him from the ground when he was finally able to get his weapon out. Trayvon Martin was no innocent black man murdered by a white person.

• Sought "justice" for Mike Brown.

A Black Lives Matter leader in New York revealed in an interview with the <u>Daily</u> <u>Mail</u> that the activist group is developing a highly trained "military" arm to lead the "war on police."

Hawk Newsome, chairman of BLM's Greater New York chapter, said the organization has military Special Forces officers training and advising members who will "patrol" black communities and challenge law enforcement.

Newsome said:

"We are preparing and training our people to defend our communities ... We are prepared to stop these government sanctioned murders by any means necessary.

We pattern ourselves after the Black Panthers, after the Nation of Islam, we believe that we need an arm to defend ourselves.

We will build and train peace officers to keep the peace in our communities, to defend our communities, to keep our communities safe."

The activist said money has been flooding into the organization from wealthy people and celebrities, specifically naming Rihanna and Nick Cannon as large contributors.

"It's our obligation, it is our duty to provide people with a pathway forward," he said.

"We want liberation. We want the power to determine our own destiny. We want freedom from an oppressive government, and we want the immediate end of government sanctioned murder by the police."

Asked about the riots happening across America, Newsome refused to denounce violence and looting, saying:

"Black Lives Matter didn't create this violence. Black Lives Matter is a product of this violence. The rioters are the product of the violence."


