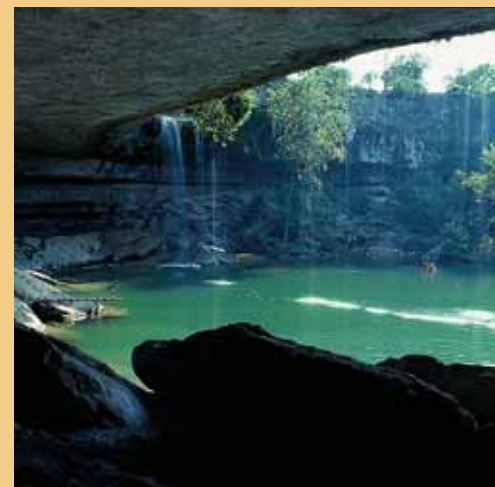

In 1987 Texas enacted the Texas Alternative Dispute Resolution Act. The Section will kick off a year long "20th Birthday" celebration of the Act with a panel composed of mediators, litigators, judges, and academics to discuss the impact of ADR on our court system and our society at large. The panel will survey current trends and discuss the future challenges of ADR as well. A case law and update on statutory developments will also be included.

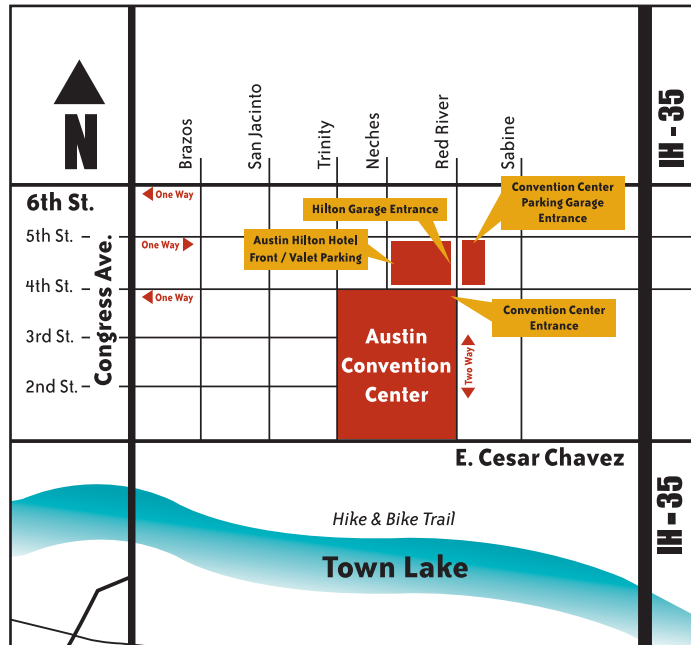
